Legislature Invites you to Attend a Public Hearing and Calls for Submissions on

the ELECRICITY REGULATION AMENDMENT BILL [B23B-2023]

The Gauteng Legislature's Portfolio Committee on Economic Development led by the Chairperson Matshidiso Mfikoe will be convening a public hearing including calling for written submissions on the Electricity Regulation Amendment Bill [B23B-2023].

The Electricity Regulation Amendment Bill, 2023 [B23B - 2023] (the "Bill"), seeks to amend the Electricity Regulation Act, 2006 (Act No. 4 of 2006) (the "Act") and the Act outlines the regulatory framework for the electricity industry and sets out the powers and role of the National Energy Regulator of South Africa (the "Regulator") in licensing electricity generation, transmission, distribution, import and export as well as trading activities. The prevailing conditions within which the South African electricity power system operates and the Department of Public Enterprises Roadmap for Eskom in a Reformed Electricity Supply Industry, 2019, are the drivers for the legislative intervention of amending the Act to provide for measures to secure energy security supply and for transitional measures towards a competitive open market.

The main purpose of the Bill is to effect amendments to the Act in order to:

- · Improve the administration of the Act;
- Provide for additional electricity, new generation capacity and electricity infrastructure;
- · Provide for the establishment, duties, powers and functions of the Transmission System Operator SOC Ltd;
- Provide for an open market platform that will allow for competitive electricity trading;
- · Assign the duties, powers and functions of the Transmission System Operator SOC Ltd to the National Transmission Company South Africa SOC Ltd;
- · Provide for delegation and assignment:
- · Provide for offences and penalties, and
- · Provide for transitional provisions.
