Adopted Report on the Configuration and Appointment of Members to House Committees

25 July 2024

The Chairperson of the Rules Committee, Honourable Speaker tables the report on the Reconfiguration of Committees in line with Rule 139(2) of the Standing Rules of Gauteng Provincial Legislature as follows:

1. BACKGROUND

The Executive Council resolved to reconfigure some functions of the Gauteng Provincial Government (GPG). The decision had a bearing on the Gauteng Provincial Legislature (GPL) in that its committees mirror the functions of GPG line departments. The alignment between spheres of government ensures effective and efficient oversight by House Committees on the Executive. To respond to the changes, the Rules Committee assessed the current location and structure of House Committees within the GPL and proposed changes to mirror the reconfigured departments within in the Executive.

This report provides an overview of the reconfiguration of House Committees in line with the changes in the GPG.
